Explanation: the P&C Federation rep for North Sydney has written to us in his official Federation capacity asking that we pass the following resolution in support of full funding for public schools. This is to help demonstrate to the state and federal governments (ahead of a critical school funding COAG meeting)

If the P&C Members agree it is resolved to pass the following resolution to be signed and returned to the P&C Federation to demonstrate Middle Harbour P&C Associations support for full funding for Public Schools

"We call upon the governments of the Commonwealth of Australia and the State of New South Wales to bring all Public schools in this state up to no less than 100% of the School Resource Standard by Year One of the New National School Reform Agreement that is due to be signed by Ministers in 2024. It is the duty of government to provide our children with a free, equitable and high-quality education, and full funding for schools is essential to carrying out this duty. Our children deserve nothing less."
